He speaks well, is interesting, and includes lots of pictures of the temples, churches and monuments he describes. The course is not your standard travelogue. It's an interesting college-level course.

Talk about being drawn into the visual world. We are hooked. Since then we have gotten a DVD course on the great civilizations of Asia Minor, and Bart Erdman's* course on Lost Christianities.

Fran is a retired teacher and English major and has always been interested in the history of religion and I'm a retired research engineer who has always been interested in physics as well as history of any kind. We enjoy each other's interests, so it looks as if we will be spending lots of time with the Teaching Company. It seems that their prices drop from quite high to very low, several times a year. That's when we get interested.

Occupational center hosts open house

The center's staff welcomes parents, other students, businesses and community members to tour and observe hands-on student demonstrations.

This campus is Silicon Valley's one-of-a-kind public career technical training facility.

CCOC, a unit of MetroED-offers more than 30 different technical training courses in the career clusters of Automotive Technology, Building Technology, Business Technology, Cosmetology, Engineering/Industrial Technology, Visual Arts, and Health and Community Services.

Both staff and student tour guides will be on hand to welcome parents, other students, businesses and community members to tour classes and observe student demonstrations

throughout the campus from 8-10 a.m., 1-3 p.m., and 6-8 p.m.

The Interior Design class will hold its annual design show featuring Cultures from around the world. Under Interior Design Instructor, Wendy Yegge, students work in small teams decorating small room settings to fit the theme on a shoe-string budget. Rooms are decorated with furniture, lighting, accessories, sound, food, and other personal touches.

Students who choose to attend the classes spend half-a-day at their regular high school and the other half of the day on the campus in the career course of their choice. CCOC serves students from 32 high schools within six school districts: Campbell Union High School District, East Side Union High School District, Los Gatos-Saratoga Joint Union High School District, Milpitas Unified School District, Santa Clara Unified School District, and San Jose Unified School District.
